Ronen Boneh is the new CEO of Elmo Motion Control

- As of September 1, 2023, Ronen Boneh (58) took over as CEO of Elmo Motion Control
- CEO Haim Monhait (70) retires after 35 years at Elmo Motion Control
- Under Boneh, continued expansion of the product range and thus supplement of the Rexroth ctrlX AUTOMATION portfolio

As of September 1, 2023, Ronen Boneh took over as CEO of Elmo Motion Control, headquartered in Petah-Tikva, Israel. Boneh has been responsible for development and product management at Elmo Motion Control since 2008. Haim Monhait, former CEO of Elmo Motion Control, is retiring effective on August 31, 2023, after 35 years with the company, but he will remain on board in an advisory capacity.

Effective from September 1, 2023, Ronen Boneh – a long-standing employee of the company – took over as CEO of Elmo Motion Control. Most recently, he was responsible for the company's development and product management. Before he joined Elmo in 2008, he was cofounder and CEO of Control & Robotics Solutions Ltd. from 1994 to 2008, until it was acquired by Elmo. As part of his previous roles at Elmo Motion Control, he has gained a deep understanding of customer applications and their technological needs and has comprehensive knowledge of the market and products.
