Dr. Jochen Peter has been a member of the Executive Board of Bosch Rexroth AG since January 2026. He took over as Chairman of the Executive Board on March 1, 2026. He is responsible for the corporate departments in charge of strategy and business development, and corporate communications.

Dr. Jochen Peter studied mechanical and process engineering at the Technical University of Kaiserslautern and also completed a degree in business administration at the Fern-Universität in Hagen. From 2002 to 2004, he worked as a research scientist at the Fraunhofer Institute for High-Speed Dynamics. He completed his doctorate, which he wrote at BMW AG, in 2004 at the Bundeswehr University in Munich.

From 2004 to 2010, Peter held various positions at The Boston Consulting Group, including assignments in the USA and Hungary, and managed projects in the automotive, healthcare, wind energy, and mechanical and plant engineering industries. Most recently, he held the position of Principal and was the European Topic Leader for the wind energy industry.

From 2011 to 2014, Peter was Head of Strategic Corporate Development at Carl Zeiss AG.

He then took over as Head of Technology and Innovation at Carl Zeiss Vision International GmbH from 2014 to 2015 and was responsible for product, process, and business model innovation within the business unit.

From 2015 to 2017, he served as CEO of Carl Zeiss Industrielle Messtechnik GmbH, with overall responsibility for the Industrial Quality Solutions business unit.

From 2018 to 2025, he was a member of the Executive Board of Carl Zeiss AG and CEO of the Zeiss Industrial Quality and Research segment.

Since January 2026, Dr. Jochen Peter has been a member of the Executive Board of Bosch Rexroth AG. He has assumed the role of Chairman on March 1, 2026, with responsibility for the corporate departments in charge of strategy and business development, and corporate communications.
