# 4. Collection, processing and use of personal data

# 4.1 Processed data categories

The following categories of data are processed:

• Communication data (e.g. name, e-mail, address, industry, IP address)

Contract master data (contractual relationship, product - or contract interest)

Customer history

Device-related data (type of device you use for the survey)

Your voluntary participation in the customer satisfaction questionnaire represents your agreement to the processing and storage of personal data in accordance with this information note. If you no longer wish to receive invitations to participate in customer satisfaction questionnaires, then please contact us at: sales@boschrexroth.ro and express this option.

4.2 Basic principles

Personal data is all information relating to an identified or identifiable natural person, such as names, addresses, telephone numbers, e-mail addresses, contractual, booking and accounting data, which is an expression of a person's identity.

We collect, process and use personal data (including IP addresses) only if there is a legal basis for doing so or if you have given us your consent, e.g. in the context of a confirmation.

4.3 Processing purposes and legal basis

We and the service providers commissioned by us process your personal data for the following purposes:

4.3.1 To identify faults and for safety reasons

(Legal basis: Fulfilment of our legal obligations in the area of data security and legitimate interest in the elimination of faults and the security of our offers).

4.3.2 Customer surveys

We process your data to improve our business relationship. For providing the Offer online / sending the information email / for voluntary participation in the satisfaction questionnaire. Legal basis: Legitimate interest from us / consent from you.

In order to improve the design of future surveys, we check the type of device you used to take the survey.

The survey link will be available for you for three weeks. After two weeks, you will receive a reminder. We do this in order to achieve the highest possible feedback rate and thus a reliable result of the survey.

Product or customer surveys by e-mail provided you have expressly agreed to this.

(Legal basis: Consent).

4.3.3 Global internal data exchange

(Legal basis: legitimate interest internal data exchange between Bosch Rexroth's various divisions)

# 4.3.4 Protection and defence of our rights

(Legal basis: Justified interest on our part in asserting and defending our rights).

# 4.4 Log files

Each time you use the Internet, your Internet browser automatically transmits certain information, which we store in socalled log files.

The log files are kept by us for at least 90 days for malfunction diagnosis and security reasons (e.g. to investigate attempted attacks) and can be used for incidents. Archived log files are stored in a compressed form for legal purposes for one year. Log files whose further storage is required for evidential purposes are exempt from erasure until final clarification of the respective incident and can be passed on to investigating authorities in individual cases.

The following information is stored in the log files:

- IP address (Internet protocol address) of the device from which the online offer is accessed;
- Internet address of the website from which the online service was accessed (so-called origin or referrer URL);
- name of the service provider via which the online service is accessed;
- name of the files or information retrieved;
- date and time and duration of the access;
- amount of data transferred:
- operating system and information on the Internet browser used, including installed add-ons (e.g. for the Flash Player);
- http status code (e.g. "request successful" or "requested file not found").

#### 4.5 Children

This survey is not intended to children under 18 years of age.

## 4.6 Service providers (general)

We make use of external service providers for tasks such as data hosting and evaluation of the survey results. We have selected these service providers carefully and monitor them regularly, in particular their careful handling and safeguarding of the data stored with them. All service providers are obliged by us to maintain confidentiality and to comply with legal requirements. Service providers may also be other companies of the Bosch Group.

# 4.7 Transfer to recipients outside the EEA

Personal data are not transmitted outside the EEA, in so-called third countries.

# 4.8 Duration of storage, retention periods

As a matter of principle, we store your data for as long as is necessary to provide our survey and to process the survey results.

## 5. Use of cookies

Within the scope of providing our survey, we only use technically necessary cookies. For this reason, no cookie manager dialogue is offered.

Cookies are small text files that can be saved on your device when you visit a website.

If you wish to switch off all cookies, please go to your browser settings and deactivate the saving of cookies. Please note that this may affect the functionality of the survey.

## 6. Security

Our employees and the service providers commissioned by us are obliged to maintain secrecy and comply with the provisions of applicable data protection laws.

We take all necessary technical and organisational measures to ensure an appropriate level of protection and to safeguard your data managed by us, in particular against the risks of accidental or unlawful destruction, manipulation, loss, modification or unauthorised disclosure or access. Our security measures are constantly improved in line with technological developments.

## 7. Rights of users

Please use the information in the Contact section to assert your rights. Please make sure that we can clearly identify you.

## Right to information and access

You have the right to receive information from us about the processing of your data. To this end, you can exercise a right of access to the personal data that we process about you.

# Right of rectification and erasure

You have the right to obtain from us the rectification of inaccurate data. If the legal requirements are met, you can demand the completion or erasure of your data. This does not apply to data which are required for billing and accounting purposes or which are subject to the legal obligation to retain data. If access to such data is not required, however, its processing will be restricted (see below).

# **Restriction of processing**

You have the right to request from us - insofar as the legal requirements are fulfilled - the restriction of the processing of your data.

## **Data Portability**

Insofar as the legal requirements are met, you have the right to request that data which you have made available to us be transmitted to you in a structured, common and machine-readable format or - insofar as technically feasible - that the data be transmitted to a third party.

## **Revocation of consent**

If you have given us your consent to the processing of your data, you can revoke this consent at any time with effect for the future. The lawfulness of the processing of your data until revocation remains unaffected.

## 8. Right of complaint to the supervisory authority

You have the right to lodge a complaint with a data protection authority. You can contact the data protection authority responsible for your place of residence or your federal state or the data protection authority responsible for us, which is the Bavarian State Office for Data Protection Supervision (BayLDA).
